Please note that Repsol requires an original voided check and cannot accept copies or temporary checks. If you do not have paper checks, we can accept a letter from your bank verifying your identity and bank account information.

If you choose not to elect in direct deposit payments, you will be paid via check. Repsol's minimum payment amount for revenue payments is \$25.00. Your balance will accumulate each month and pay out once the \$25.00 minimum is reached.

Please allow 30 – 60 days for setup, changes, or termination of automated payments. During this period, you will continue to receive physical checks via U.S. mail.
